Daleiden and Merritt — deceitful liars or heroes?

Nearly two weeks ago the FBH severely castigated pro-lifers David Daleiden and Sandra Merritt's efforts to expose

Planned Parenthood for illegal fetal harvesting. They were judged to "deceitful liars" whose indictrecent further ments proved thev were guilty of wrongdoing. Allow me as pastor to offer an alternative view.
